# Waverley A&P Doubles Power Fencing Competition

## Specifications and Rules

**SPECIFICATIONS:** Competitors must erect 30 metres of 5 wire electric fence. The fence will consist of one 2.4metre stayed strainer assembly and one 2.1metre blocked strainer assembly with 7 wooden posts, a steel pipe gate – hung and latched and an electric Tape gate at the other end.

2.4metre Stayed Strainer	-	1175mm
2.1metre Blocked Strainer	-	1000mm
1.8 ¼R Posts	-	1000mm
Post Spacings	-	5 metres to ground
Wire Tension	-	100kg

Wire spacing from top, 75mm, 315mm, 515mm, 685mm, 835mm, the end strain insulators will be tied 125mm from the strainer, with 6 tight wraps.

PA 40 cut-out switch will be positioned between the top and second wire on the 2.1metre blocked strainer and connected with a tail off the fence. Both ends must be clamped. 200 x 50 connect to second wire up, don't bend, lazy loop.

A Tape gate will be positioned 75mm from top of post with an inside measurement of 3 metres.

## **RULES:**

- Competitors must supply their own tools unless stated.
- Competitors must not infringe on other lines.
- Safety footwear must be worn.
- No drop starting of chainsaws and only trained competent operators to use.
- Chainsaw chaps and safety glasses must be worn while chain sawing.
- Eye protection/safety glasses to be used during ALL wire work.
- Ear protection while using motorised equipment.
- No material will be prepared before competition.
- Only supplied materials can be used on fence line
- 21m.m bit for Lock Thru Gudgeon.
- Time point penalty – 1 per minute after first team has finished and called time

Judging includes safety penalties for unsafe practices. If the practice is observed beyond a one off occurrence a verbal warning and correction advice to the competitor will be issued by the judges and full safety penalties will be awarded on doing so.
